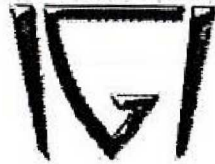

This 29-acre vineyard sits atop one of the highest points in the Castillon appellation. The 32-year old vines, 75% Merlot and 25% Cabernet Franc, are planted in thin clay soil that barely covers the deep limestone subsoil making it very akin to that of the Saint Emilion plateau. Small wonder that Juliette Bécot and father Gérard, owner of Beau-Sejour-Bécot and La Gomerie, were attracted to this unique site. Juliette lavishes the same attention on Joanin as does her father on his vineyards : leaf-pulling, crop-thinning, hand-harvesting and sorting are the rule here where she keeps yields deliberately low. After a 41-day maceration in stainless steel tanks, the wine does its malo and is aged for 16-18 months in barrels, 70% of which are new. Juliette's goal is to capture a maximum of bright fruit flavors against a layered background of supple tannins. In short, to respect and reflect the essence of her terroir.
