2016 CABERNET SAUVIGNON | PASO ROBLES

The fruit was grown in the Paso Robles Appellation which has a long tradition of producing excellent Cabernet Sauvignon. Picked at a point where they would produce a wine that is complex and balanced, the grapes were crushed and fermented in stainless steel vessels and barrel aged in a combination of American and French oak barrels for 30 months. This wine has a very rich dark hue that is characteristic of grapes from Paso Robles. It has a mixture of the aromas of raspberry, plum and cherry with notes of tobacco leaf, white pepper and fresh thyme. The wine has an earthy entry but evolves into ripe red fruits of raspberry, cherry and strawberry with hints of vanilla.
