*From some of the oldest vineyard blocks on Red Mountain, we hand harvest Cabernet Sauvignon, Merlot, Cabernet Franc, and Petit Verdot for this wine. Ciel du Cheval is consistently muscular with brooding elegance, substantial tannin structure, and remarkable fruit density.*
