Since the acquisition of Domaine de Baronarques in 1998 by Baroness Philippine de Rothschild and her two sons, Philippe Sereys de Rothschild and Julien de Beaumarchais de Rothschild, its wines have set the standard for one of France's oldest winegrowing regions. The property is planted with Bordeaux varieties (Merlot, Cabernet Franc and Cabernet Sauvignon) and Mediterranean varieties (Syrah and Malbec). A complex blend in the Mediterranean style gives La Capitelles de Baronarques its generous fruit, spice notes and refined aromas and flavours. The name Capitelles is a reference to the dry-stone huts built by Languedoc winegrowers in the 19th century.
