Abbess de Loire *Crémant de Loire* *Appellation Crémant de Loire Contrôlée* **SPARKLING ROSE WINE**

Our Crémant pays tribute to Louise de Bourbon and thirty-five other Abbesses who reigned at the Abbaye de Fontevraud from 1115 to 1792. Louise oversaw the expansion of the abbey between 1534 and 1575. Her motif, the L ailé (winged L) can be found throughout the building, in carved marble panels and decorative floor tiles. We crafted our Crémant rose from the region's classic red grapes using the same methode traditionnelle as the finest French sparkling wines. After 12 months ageing in the bottle, our rose is a beautiful pale salmon pink, with a fine lively mousse and complex summer berry fruit notes.
