The grapes for the Kirkland Signature Chianti Classico are grown on the rolling slopes within the Chianti Classico region. Created by the wine making team of the Villa Cafaggio Estate, Kirkland Signature Chianti Classico has aged for a minimum of 24 months of which at least 3 months in bottle. The resulting wine has an intense dark color with aromas of ripe fruit and wild herb. The palate boasts deep Morello cherries with black currant undertones.
