CABERNET SAUVIGNON

Château Tanunda, Icon of the Barossa, was established in 1890 and is the site of some of the Valley's earliest vines as well as its first winery. The Château is privately owned by the Geber family who continue a tradition of fine winemaking spanning three centuries.

Open fermentation of small individual parcels and careful basket pressing have resulted in a full-bodied Cabernet Sauvignon. Lifted aromas of blackcurrant, plum and violet are supported by dark berry fruits and vanilla on the palate. The extensive finish is framed by elegant, fine-grained tannins from maturation in a combination of new and seasoned French oak barrels.
