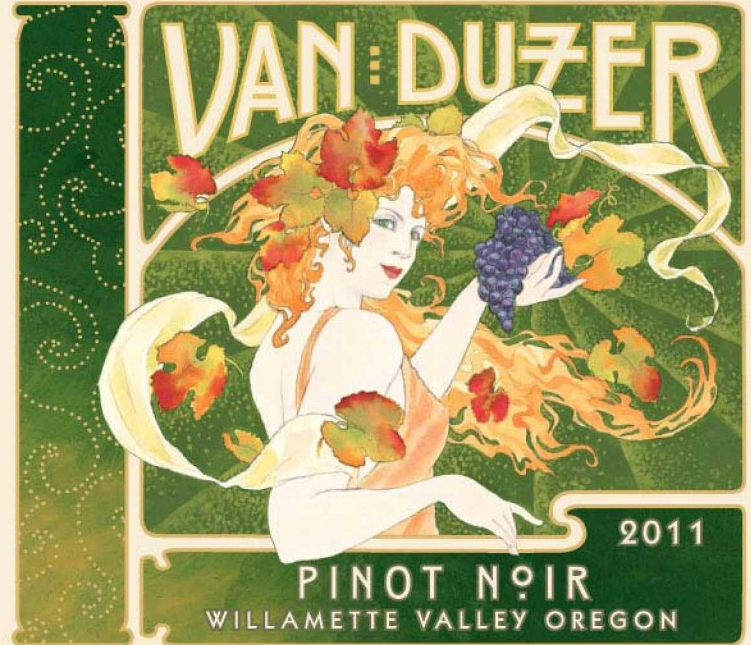
2011 PINOT NOIR WILLAMETTE VALLEY
