This is our second release from this three acre bench-land vineyard in Dry Creek. As with most Sonoma zinfandel, in 2018 the vines set a full but balanced crop. Warm summer weather subsided in the last half of August. The cooling trend extended the ripening period, allowing flavors to fully develop. Ten months aging in american oak brings spice to the plentiful fruit. Enjoyable now, this classic Dry Creek zinfandel will evolve over the next six years. JO (6/19)
