At Lagar de Codegua we produce only limited quantities of wines from a single vineyard in the Alto Cachapoal Valley, located at the feet of the Andes Mountains. The unique combination of clear skies, cool nights and gravelly soils give our wines their intense color, elegant tannins and expressive fruit character.

The grapes were handpicked. Aged for 8 months in oak barrels this wine was bottled without fining or filtration. 2,500 cases produced.

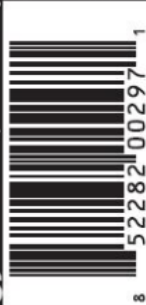
