This 1865 wine honors Vitis San Pedro's founding year. It's crafted from carefully selected grapes from Maipo Valley. Located in Pencoche, 300 km (186 mi) from Santiago, the Las Moradas Vineyard is planted on soft rolling hills with presence of minerals like magnesium and basalt, which gives the soil a characteristic purple color, from which the name of the vineyard derives. The wine opens with ripe fruits, blackberry and plum, and subtle hints of species like cloves, black pepper, tobacco and cedar. The palate is very persistent and smooth, and precision shines through in every detail.

1865 honora el año de fundación de Vitis San Pedro. Este vino ha sido elaborado con uvas cuidadosamente seleccionadas del Valle del Maipo. En este valle se encuentra el viñedo Las Moradas, en una localidad llamada Pencoche, a 300 km de Santiago. Este viñedo se emplaza en suaves colinas, con presencia de minerales como magnesio y basalto, aportando al suelo una tonalidad morada característica de donde se origina su nombre. El vino se abre con notas a fruta madura, frutos negros y ciruela además de un toque sutil a especias como clavo de olor, pimienta negra, tabaco y cedro. De paladar muy persistente y suave, la precisión brilla en cada detalle.
