1805 marks the year Lewis & Clark discovered Washington's Columbia River Valley. Wine grapes were soon planted in the region and have been cultivated there ever since.

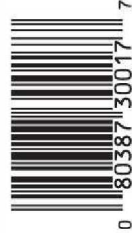
