Since 1890 when Quinta dos Malvedos was originally purchased by Graham's, two small stone-terraced vineyards on the estate have been prized for their unique characteristics. The eastern facing 'Port Arthur' vineyard has just 1,379 vines on 11 stone terraces and the northerly facing 'Vinha dos Cardenhos' vineyard has 1,329 vines, also on narrow stone terraces. Both vineyards have low yields but they make wines of extraordinary quality and concentration. This Vintage Port is a tribute to the men and women of the Douro who built these beautiful dry-wall stone vineyards in the 18th Century.
