 Best served at 18 °C (64 °F).

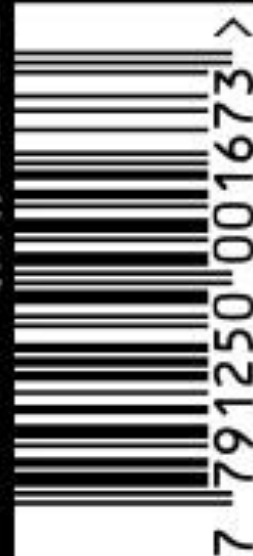
