Tun 1401 is The Balvenie's *traditional oak marrying vessel* and is cared for by the distillery's onsite team of coopers. The sixth batch to have rested within is *fragrant, fruity and malty* on the nose with barley sugar sweetness and soft vanilla. The taste is sweet at the start, followed by a *luscious explosion of tangy citrus and gentle spices*. Mouth-filling honey combines with *vanilla syrup and hints of oak tannin*. The finish is rich with a lingering sweetness.
