The 2008 Cabernet Cuvée is decadent and full, densely layered and full-bodied. The grapes are sourced from some of the highest quality vineyards that call Sonoma County home. The final blend is predominately Cabernet Sauvignon with a small percentage of Petite Verdot which adds some roundness and even more delectable body. Big oak is also a profile for this wine style. The new oak tannins are very big, yet very well integrated. Overall, a very 'Cabernet-style' Cabernet. Quite delicious, silky, lush and multi-layered. Drinkable now, but will age very nicely for another 5-10 years easily.

Food Pairings: filet mignon with a black peppercorn sauce, lamb chops with rosemary and dark chocolate.
