The Beit El winery is located adjacent to the site of our Father Yaakov's dream, where the Bible describes our forefather dreaming of a ladder extending fully to the heavens, with angels ascending and descending. Upon waking, Yaakov thought fervently "Surely Hashem is in this place," (Genesis 28:16) and he then named the site Beit El, which in Hebrew means the house of God.

Tasting Notes

The Amona vineyards is 900 m above sea level only 15 minutes from Beit El winery. The Mediterranean Sea is easy to identify to the west, and to the east, the mountains of Moab. This single vineyard Cabernet Sauvignon is deep purple-black. It offers tastes of plum and warm blackberries, pleasant tannins, and a long finish. This wine can be enjoyed with hearty meat meals for many years to come. This limited addition of 300 cases is a wine that will be remembered.
