2011 CABERNET SAUVIGNON

Established by Dr John Lagan in the 1970's, Xanadu is one of the pioneering wineries in Margaret River.

Fruit from the classic 2011 vintage was fermented in small batch static, and open fermenters. After fermentation 35% of the components were given a period of extended maceration on skins before a very gentle pressing. The wine was matured for 14 months in French oak (40% new barriques) before the blend was assembled.

This Margaret River Cabernet Sauvignon is brimming with characteristic blackcurrants, mulberries and plums all seamlessly framed by fine French oak. The wine has a generous and beautifully structured palate, layered with dense fruits of the forest, ripe tannins and a persistent fruit finish.

It will reward medium to long term cellaring.
