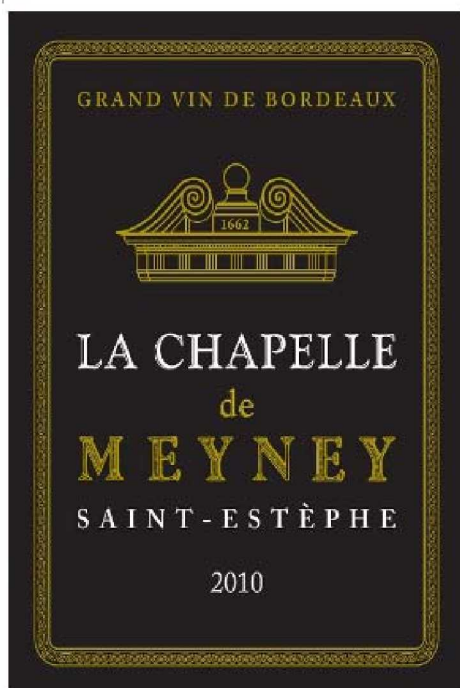
La Chapelle de Meyney is the 2nd wine of Chateau Meyney, one of the oldest estates in the Medoc region of Bordeaux. Flanked by Chateau Montrose (2nd growth) and Calon Segur (3rd growth), the property's vines are situated on a knoll that overlooks and extends to the Gironde River. Originally constructed as a Cistercian monastery in 1662, the estate benefitted from the expertise of the monks who cultivated the first vineyards. Meyney has 126 acres of vineyards in one single block of land planted on an exceptional terroir of Garonne gravel. Grapes are harvested manually, sorted in an optical sorting table to select only perfectly ripe berries, then fermented in small cement vats by parcel and varietal. The wine is aged 16 months in French oak barrels, of which 50% are new. This exceptional wine has a deep ruby color and aromas of black berries, licorice, brioche buns and sweet spices. Rich and fruity in the mouth, this elegant wine pairs with poultry, grilled meats and aged cheese.
