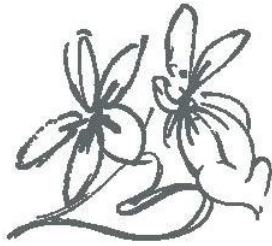

Xavier Weisskopf tends 32 acres of predominately pre-WWII vines in the Loire Valley. Most are Chenin Blanc in the small Montlouis appellation, one of the world's oldest and finest sites for this superb grape, and from these vines he makes several excellent cuvées and an artisan *pétillant*. Among his other vines are Cabernet Franc and Cot (Malbec) for appellation Touraine wines. Xavier farms these old vines diligently without chemical fertilizers or synthetic sprays, and harvests by hand.
