RED WINE / PRODUCT OF SPAIN / GARNACHA TINTORERA
From the highest and coldest areas of the region of Almansa, on limestone soils and very poor in nutrients, situated at an altitude close to 1000 meters above sea level, there are old garnacha tintorera vines with very low yields, producing wonderful grapes (of very high concentration) grouped into solitary small clusters. ALAYA is the result of the development of these fruits in small (stainless steel) tanks, the fermentation has finished in new French and American oak barrels, where it remained for 15 months before being bottled. Opaque black color, elegant nose with powerful black fruits memories that stick out above the noble wood aromas of the barrel where it has aged, the mouth is very wide, enveloping, and kind with a lengthy and scintillating final.
