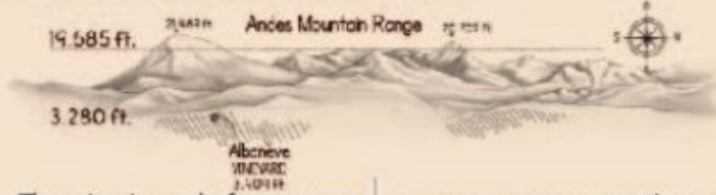

The wine is made from grapes grown in our highest altitude estate vineyards, using the most stringent vineyard management. We adapt our knowledge of viticulture and winemaking to enhance the optimal expression of each grape variety.

The average yield is a low one and a half bottles per vine to

encourage concentration and complexity in the wine. The grapes are hand-harvested and this Cabernet Franc is aged in french oak barrels for 12 months.

To appreciate this wine's rich and complex characters, we recommend serving between 59-61°F.
