Alberti 154 is the street address for Bodega Calle Winery located in the heart of Mendoza's acclaimed wine region, Luján de Cuyo. A small-lot, gravity-flow, red wine production studio, great emphasis has been placed on gently crafting wines with regional distinction and grand personality. This limited release Tempranillo was selected from prized old-vine vineyards from Altamira in southern Mendoza. A long growing season, very cold nights and low yields helped create a wine that is extremely concentrated in notes of berry fruit, but at the same time elegant. It was aged for 8 months in new and used American oak.
