+ Story: This wine was made from meticulously tended Malbec grapes grown over 4,000 feet above sea level in the foothills of the Andes Mountains. Row after row of vines emerge from the imposing backdrop of snow capped peaks and bear fruit that produces a red wine with dazzling dark fruit flavors and a cozy texture. After harvest the wine is aged in French and American oak for a minimum of six months.

+ Taste: Aromas of fresh black currants, raspberries and plums with a hint of dark chocolate. Take a sip and the wine impresses you with its lacy touch and shapely finish. You might say it's rather attractive for a beautiful wine with a great body. Serve it up with grilled flank steak and avocado relish, and a side of parmesan zucchini fries.
