Vinification

Fruit was hand-harvested at night. This Tablas Creek clone was hand sorted; clusters were all destemmed; 6 days of cold soak, gentle punch downs 1-3 times daily, 26 days on skins & gently basket pressed. Gravity fed into French oak barrels (35% new). Aged 15 months on lees, gently fined, bottled unfiltered.

Site

The Annadel Gap Vineyard is a special place. Located in the narrow windswept corridor of the northern Sonoma Valley, our site is characterized by thick morning fog and strong afternoon winds. Alluvial, glacial, and sedimentary influences create a wide array of soil types. Ideal growing conditions, varied soils, and our minimal-impact farming methods yield precise, balanced fruit.
