Alexander Valley is named after a man who arrived here on horseback in 1840. Pioneer Cyrus Alexander had ridden from San Diego, hired by Captain Fitch to look for unclaimed, frontier land suitable for ranching.

A Pennsylvanian who sought adventure and fortune as a trapper in the Rocky Mountains and later as a gold miner in California, Alexander identified 48,000 acres of land which Fitch then acquired as a grant from the Mexican government. Fitch hired Alexander to set up a working ranch and promised to award him with land of his own. The Mexican land grant became Rancho Sotoyome, and when Cyrus Alexander settled there in 1841, the as-yet-unnamed valley was the northern frontier of Mexico.
