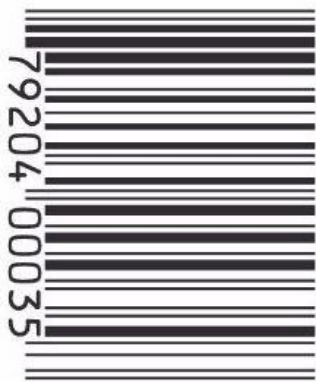
2015 CHARDONNAY

This Chardonnay was harvested exclusively from our Stevens Road vineyard which is situated on the Boodjidup Brook. This very limited release wine acknowledges the outstanding quality that this single vineyard has the ability to produce.

Hand-picked Gin Gin clone Chardonnay was whole bunch pressed and barrel fermented in a selection of fine French oak barriques (25% new) using wild yeasts. Barrels were stirred regularly throughout the nine month maturation period without any malolactic fermentation.

A stylish, intricate Chardonnay which highlights the unique personality of this special site.
