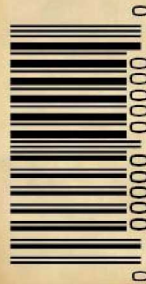
RECIPES

Barbaola 1 part Barbarossa Spiced Rum, 2 parts cola. Mix in a glass filled with ice and garnish with a lime wedge.
