On the palate, this wine is elegant, deep and full-bodied, with velvety tannins and a sublime and balanced finish.

At Lagar de Bezana we only produce a limited number of cases of wines from our single vineyards located in the foothills of the Andes Mountains. We believe that making wines is an art, which is represented through the drawings on our labels by famous Chilean artist Bororo (Carlos Maturana).

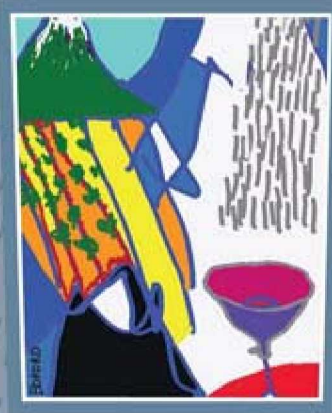
