## 5 SENTIDOS

100% DESTILADO DE AGAVE

This batch of Papalote y Chino was distilled by master distiller Delfino Tobón Mejía in San Pablo Ameyaltepec, Puebla. The fourth-generation distiller roasted Papalote (A. Potatorum) and Chino (A. Sp) hearts in an underground earthen oven with tehuixtle and mesquite firewood for three days. After roasting them, he titrated the cooked hearts with a mechanical mill and then allowed them to ferment with natural airborne yeasts and local spring water for ten days. By weight, he estimates the mash-build is 90% Papalote and 10% Chino, a rare, dark green, wild-growing species that looks like a very big Papalote and has curly spines. Once the mash reached its optimal fermentation point, Delfino distilled it once in his home-made "lentil" reflux still, which is composed of a copper boiling chamber, three copper plates housed in a water bath, and a copper condensing coil. The result was approximately 80 liters. Produced June 2018.

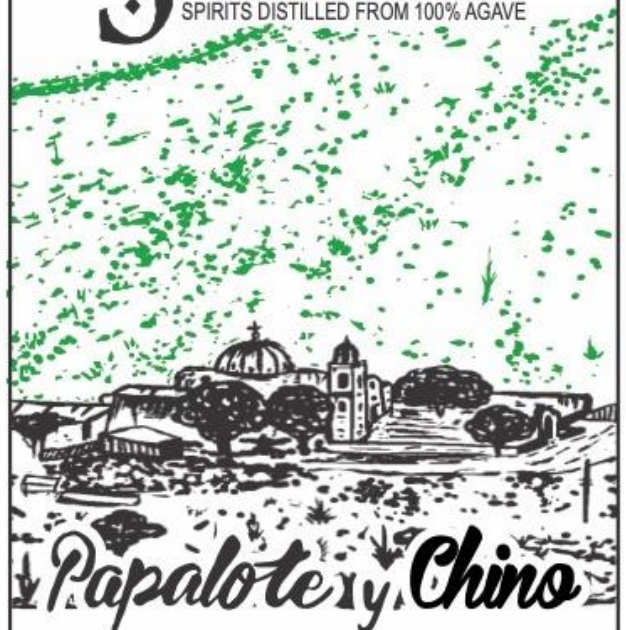
