

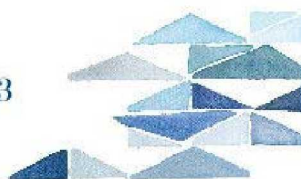

The resulting wine was the reward of those efforts and used to celebrate harmony.

A very complex wine with aromas of fresh-cut grass, passion fruit and grapefruit, all framed by mineral notes.

Perfect to be enjoyed with oysters, ceviche, shell-fish and grilled white fishes in general. Serve at 53F.

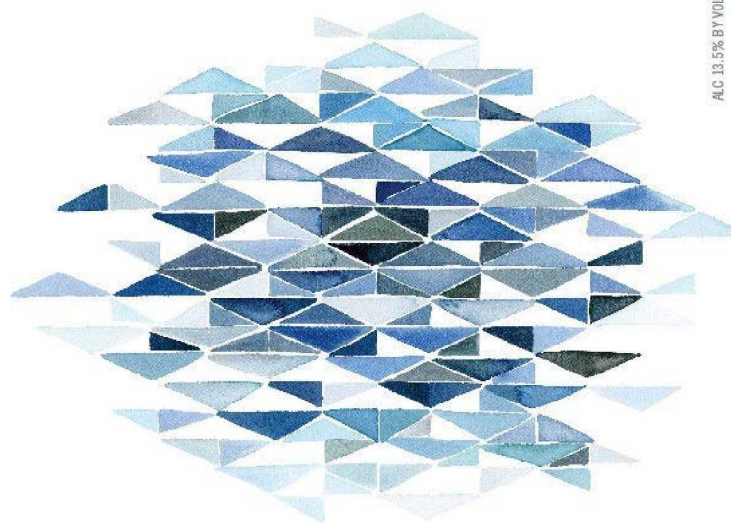
