A rich violet color of this wine combines the earthy, black-pepper aromas with gentle influences of French oak. The fruit flavours of cassis integrated with soft tannins result in a wine that is full-bodied and ready to drink now or to be aged.

The La Madras Vineyard is at an altitude of 2800 feet where the grapes receive 300 days of sunshine. The combination of the micro climate, the alluvial mix of sand and fine top soil and the water of the mineral rich runoff in the mountains, produce wines of clearly defined varietal characteristics and depth of unique complexity.
