To celebrate the region we blended 30% CABERNET SAUVIGNON for elegant structure, 30% ZINFANDEL for pepper and spice, 20% SYRAH with lush berry flavors, 10% MERLOT for rich power, 5% GRENACHE for fruitiness, 4% MOURVEDRE for texture and 1% VIOGNIER for floral aromatics. In the glass there is rich texture with flavors of boysenberry, blueberry, cherry, vanilla and spice along with a long lasting finish.
