THE MAVRODAPHNE OF PATRAS APPELLATION WAS ONE OF GREECE'S ORIGINAL DESIGNATIONS. IT IS BEST-KNOWN GREEK RED CULTIVAR IN EUROPE. IT IS AGED FOR ABOUT SIX YEARS, AND IS RICH, RAISINY, PLEASANTLY BITTER AND RED-LEANING TOWARDS-DARK-AMBER IN COLOR. COMPARISONS TO OTHER RED DESSERT WINES ARE NEITHER PARTICULARLY HELPFUL NOR FAIR, BECAUSE IT OCCUPIES A FAIRLY UNIQUE LOCATION WITHIN THE TASTE-SPECTRUM OF SUCH WINES. AGROS MAVRODAPHNE IS DISTINCTLY ON THE WINE SIDE OF PORT. ITS COMPLEXITY AND COCOA MAKE IT TOO ECLECTIC TO FIT EASILY INTO THE DESSERT WINE CATEGORY BUT CAN BE PERFECT MATCH FOR CHOCOLATE LAYERED BAKLAVA AND RICH WHITE OR DARK CHOCOLATE MOUSSE
