wine that adds an extra dimension of candied fruit, apricots and orange
peel that give way to hints of toasted hazelnut and buttery brioche.

The slightly nutty characters on the palate lead to subtle gingerbread
flavours with an underlying freshness that ensures longevity and elegance
whilst the intense, opulent fruit flavours fill the mouth.

Try with a creamy chicken dish, forest mushroom risotto or pasta
with clams in white wine sauce.
