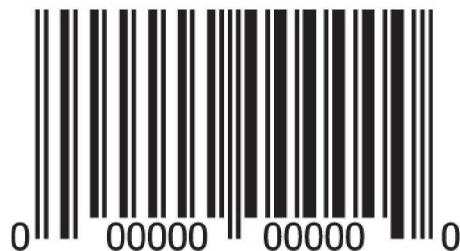

THIS WINE IS EXCLUSIVELY MADE OUT OF THE PIQUEPOUL GRAPE, A VERY ANCIENT VARIETY GROWN IN THE PINET TERROIR, BY THE MEDITERRANEAN. A FRUITY AND CRISP WINE, TO ENJOY ON ITS OWN AS AN APERITIF, OR AN EXCELLENT PARTNER TO OYSTERS, LOBSTER, FISH AND OTHER SEAFOOD.
