

## Terms of Service

Latest update: 15 December, 2023

The Concorpad website is owned and operated by Tacans AG d/b/a Concorpad (“Concorpad,” “we,” “us” or “our”). These Terms of Use (these “Terms”) govern your access to and use of the Concorpad website; including without limitation the creation, purchase, sale, exchange, or modification of certain digital assets; our online and/or mobile services, and software provided on or in connection with those services (collectively, the “Service”).

This Service also allows you to sell and purchase Crypto Assets (as defined below) fixed price or via auction (the sale and purchase of Crypto Assets fixed price and/or via auction hereinafter are referred to as “Auction”). You may participate in the Auction by linking your digital wallets. Besides, you may choose to make payments with your fiat money banking cards (i.e., credit cards) employing a respective feature of the platform. Before putting up your unique digital asset for Auction or putting in an offer to purchase a unique digital asset from another user, we will ask you to download a supported electronic wallet extension and connect and unlock your digital wallets with that extension. Once you submit an order to sell or purchase a unique digital asset, your order is passed on to the applicable extension, which completes the transaction on your behalf.

“Crypto Assets” refers to unique non-fungible tokens, implemented on the Ethereum blockchain, the Concordium blockchain and the other blockchain as the case may be (the “Blockchain Platform”) using smart contracts.

All transactions initiated through our service are facilitated and run by third-party electronic wallet extensions, and by using our services you agree that you are governed by the terms of service and privacy policy for the applicable extensions.

Concorpad is a platform. We are not a broker, financial institution, or creditor. The services are an administrative platform only. Concorpad facilitates transactions between the buyer and seller in the auction but is not a party to any agreement between the buyer and seller of crypto assets or between any users.

You bear full responsibility for verifying the identity, legitimacy, and authenticity of assets you purchase on Concorpad. Concorpad makes no claims about the identity, legitimacy, or authenticity of assets on the platform.

Because we have a growing number of services, we sometimes need to describe additional terms for specific services. Those additional terms and conditions, which are available with the relevant services, then become part of your agreement with us if you use those services.

By completing the account registration process, using our Services and/or purchasing Crypto Assets, you agree to be bound by these Terms and all the terms incorporated herein by

reference. If you do not agree to these terms, you may not access or use the Service or purchase the Crypto Assets.

Concorpad reserves the right to change or modify these Terms at any time and in our sole discretion. If we make changes to these Terms, we will provide notice of such changes, such as indicating the “Last Updated” date at the beginning of these Terms. By continuing to access or use the Service, you confirm your acceptance of the revised Terms and all the terms incorporated therein by reference.

Please refer to our Privacy Policy for information about how we collect, use and share personal information about you.

If you wish to participate in an Auction for Crypto Assets, you will need to register for an account on the Service (“Account”). By creating an Account, you agree to (a) provide accurate, current and complete Account information about yourself, (b) maintain and promptly update from time to time as necessary your Account information, (c) maintain the security of your password and accept all risks of unauthorized access to your Account and the information you provide to us, and (d) immediately notify us if you discover or otherwise suspect any security breaches related to the Service, or your Account. Concorpad will block multiple accounts of the same user. Also, you agree that you will not (i) create another account if we have disabled one you had unless you have our written permission first; (ii) buy, sell, rent, or lease access to your Account or username unless you have our written permission first; (iii) share your Account password with anyone; or (iv) log in or try to log in to access the Service through unauthorized third party applications or clients.

Concorpad may require you to provide additional information and documents at the request of any competent authority or in case of application of any applicable law or regulation, including laws related to anti-laundering (legalization) of incomes obtained by criminal means, or for counteracting financing of terrorism. Concorpad may also require you to provide additional information and documents in cases where it has reasons to believe that (i) Your Account is being used for money laundering or for any other illegal activity; (ii) You have concealed or reported false identification information and other details; or (iii) Transactions effected via your Account were effected in breach of these Terms.

In such cases, Concorpad, in its sole discretion, may pause or cancel your Auction transactions until such additional information and documents are reviewed by Concorpad and accepted as satisfying the requirements of applicable law. If you do not provide complete and accurate information and documents in response to such a request, Concorpad may refuse to provide the Content (defined in Section 4(A) below) to you.

By creating an Account, you consent to receive electronic communications from Concorpad (e.g., via email or by posting notices to the Service). These communications may include notices about your Account (e.g., password changes and other transactional information) and are part of your relationship with us. You agree that any notices, agreements, disclosures, or other

communications that we send to you electronically will satisfy any legal communication requirements, including, but not limited to, that such communications be in writing. We may also send you promotional communications via email, including, but not limited to, newsletters, special offers, surveys and other news and information we think will be of interest to you. You may opt out of receiving these promotional emails at any time by following the unsubscribe instructions provided therein.

By submitting personal data through our site or Services, you agree to the terms of our Privacy Policy, and you expressly consent to the collection, use and disclosure of your personal data in accordance with the Privacy Policy
