AGREEMENT TO TERMS

These Terms of Service constitute a legally binding agreement made between you, and Digirealm Cloud Technologies Kenya Limited (“we,” “us” or “our”), concerning your access to and use of the <https://www.legalpointservices.com> website as well as any other media form, media channel, mobile website or mobile application related, linked, or otherwise connected thereto (collectively, the “Site”).
