**MEMORANDUM OF MUTUAL COOPERATION**

This Memorandum of Mutual Cooperation is between the **Soldiers of Peace International Association (SPIA)**, a INGO, registered at Lyon, France and headquartered at SPIA Central Office, 178 Rue Garibaldi Street, Lyon, 69003, France, represented by the Director for Southern European Affairs, **Mr. Pavlet Naidenov**, AND **"Tesla Technologies" Ltd**, Identification number 12152564 and headquartered at the address: 179 Torridon Road, London, United Kingdom, SE6, 1RG hereinafter referred to as the Parties.


The Parties have signed the present Memorandum of Cooperation in fulfilment of their intention of attaining common goals for the maintenance and strengthening of peace and international food security, supporting of development of World Without Hunger, socio-economic rehabilitation and, in particular, relief, peace support and humanitarian assistance operations within the guidelines, goals and objectives of the United Nations in cooperation with relevant government departments in the France, Switzerland, UK, Hungary, Bulgaria, Uganda and other UN Members States.

The Parties have further agreed that they intend, subject to contracts yet to be drawn up, to pursue:

- The initiation of SPIA - "Tesla Technologies" Ltd cooperation based on open dialogue partnership;
- The creation of a SPIA - "Tesla Technologies" Ltd Cooperation activity comprising of people and/or organisations with relevant Peacekeeping & Humanitarian Assistance experience and skills and approved by the Parties;
- The planning, preparation and execution of activity in cooperation with UN, EU, OSCE, NATO Partnership for Peace Program, AU, CIS, ODKB-CSTO, SECTSCO, BRICS, GCC, ASEAN, Organization of American States, Community of Latin American and Caribbean States, G-20 states and on level of other International Organisations, which response for multinational Peace Support & Humanitarian Assistance Operations and Mine Actions;
- The establishment of other appropriate joint activity on UN, EU, OSCE, NATO Partnership for Peace Program, AU, CIS, ODKB-CSTO, SECTSCO, BRICS, GCC, ASEAN, Organization of American States, Community of Latin American and Caribbean States, G-20 states and other International Organisations level;
- Supporting of SPIA and "Tesla Technologies" Ltd Public activity with using of mechanism and instruments of collection of private donations and power of charity organisations, UN vendors, and commercial partners via UNIFICI Foundation.
- To represent interests of each other on level of World Food Program, Hungary, African Countries and abroad, establishment of Joint representative bodies on the territory of the UN Peace Support Operations contributors countries and in other independent states in the region yet to be defined;
- Cooperation in the appropriate joint dissemination of experience gained in this major Peace Support & Humanitarian INGO's
