Teijin Frontier brings stability to its operations and enhances its corporate value by promoting CSR procurement and actively engaging in corporate initiatives that encourage responsible conduct through activities that impact social and environmental issues. We continuously apply PDCA cycles when conducting supply chain management and, when we detect issues, we work out improvement measures with our suppliers and provide ongoing support. In addition to additional policies and standards, we have established a set of CSR procurement standards (quidelines) for our suppliers that act as a foundational document governing all CSR procurement activities. These CSR procurement standards are in full compliance with the laws and regulations of each country in which we operate,

as well as international guidelines, such as the UN's Guiding Principles on Business and Human Rights, which requests that all corporations and nations elevate their protection of human rights and improve

We require suppliers to fill out self-assessment questionnaires (audits) that allow us to confirm conditions in terms of human rights and labor, safety and health, environmental conservation, compliance and quality etc. The questionnaire results are then used to plan on-site inspections (audits).

We also conduct fact-finding surveys (audits) that examine the labor conditions and work safety at our suppliers.
