
### **Updates: Patents orders and Judgments**

Unwired Planet International Ltd and another v Huawei Technologies (UK) Co Ltd and another.

Case ID: UKSC 2018/0214

The cases concern a number of patents, which are declared to be essential to the practice of numerous telecommunications standards, Respondents has commenced proceedings against the respective Appellants for infringing those patents. The Respondents are under an obligation to make available standard essential patents on fair, reasonable and non-discriminatory terms.

Standard Essential Patents: Nokia v. Daimler (2 O 34/19)

Nokia won a patent dispute against Daimler AG, after a long-running fight over mobile technology in automobiles. The German court ruled that Daimler violated Nokia's mobile-technology patents. The court said that "it had to side with Nokia because Daimler wasn't willing to abide by existing rules for so-called Standard essential patents".






### **National Intellectual Property Literacy initiative: Ministry of Education**



Recently, it was proposed to form a State IP Policy by the Chairman of CII National Committee on Intellectual Property, Shri Ramesh Datla for the state of Telangana. Further, in association with the Confederation of Indian Industry (CII), the Telangana Government has proposed the establishment of a taskforce to promote enforcement of Intellectual Property Rights in the state. These disclosures were made at a virtual IP conference titled "Enabling Enterprises and Innovators to Strategize IP for a self-reliant India" dated 29th July 2020.



Apple Inc. has to pay \$506 million by way of damages to Optis Wireless Technology for patent infringement involving seven patents related to 4G LTE technology.



# TM Protection: Golden Lindt easter bunny

It is well know that Lindt has been trying for many years to obtain trademark protection for the famous Golden Rabbit, but the attempt to obtain comprehensive protection as a 3D trademark was considered a failure because the elements of the mark applied for (shape, gold foil and red ribbon with bells) could not give the mark any distinctive character. However, the Swiss chocolate manufacturers were now trying to protect the color gold in the golden rabbit as a colour trademark because the gold colour shown on the packaging foil of the chocolate bunnies is so well known through years of intensive advertising and use that now this gold color is generally associated with the Lindt Golden Rabbit/ Easterbunny by the consumers.




### **Shape Mark: BGH and Ritter Sport**

The Data Access Corporation has filed a trademark infringement suit against tech giant Microsoft, alleging infringement of its "DATAFLEX" trademark. Microsoft did not respond to a cease-and-desist notice issued by Data Access and continued to advertise its products under the "DATAFLEX" trademark.

The automobile manufacturer Jaguar Land Rover (JLR), did not receive a favourable decision in its bid to obtain trademark protection over the shape of its Defender' SUV. This application allows users to find, prepare and organizeheir meal plans, and consists of a green pear-shaped logo with a right-angled leaf. Further, the Apple has claimed that it has previously created mobile applications in the category of health and nutrition, and therefore the usage of the pear-shaped logo might lead to consumer confusion, as consumers may associate Prepear as a product of Apple.

The US based nWay, has collaborated with a company called World Wrestling Entertainment (WWE) to develop and publish a new



# India's first copyright guide released for public consultation


The National Digital Library of India has released the draft of India's first Copyright Guide for Indian libraries. The deadline for submitting public review feedback is September 30, 2020.

Disney Enterprises, Inc. and Ors. Vs. Kimcartoon.to and Ors., Delhi High Court, CS(COMM) 275/2020.

The plaintiffs filed a lawsuit against the defendants for streaming original and copyrighted content created by the plaintiffs, without acquiring any prior authorisation from the plaintiffs. The court held that the defendants were violating the plaintiffs' copyright, by infringing upon their content after reviewing the list of the infringing websites, submitted by the plaintiffs, and the content being made available on those websites

### **COPYRIGHTS HIGHLIGHTS**

VinayVats Vs. Fox Star Studios India Pvt. Ltd. and Ors., Delhi High Court, I.A. 6351/2020 in CS(COMM.) 291/2020.

In this case the court observed that, copyright can only be granted for the expression of an idea and not for the idea itself, and that idea can be expressed inseveral forms. Further, in order to confirm whether or not two films are exactly the same in terms of the execution, the most reliable way to dodetermine that, is to see the audience's reaction to both the films. If the audiences find any similarities in both the films, then the next step is to ascertain the extent of such similarity.

### Listing of GI registered products: Government holds discussion with e-commerce platforms

The Department for Promotion of Industry and Internal Trade (DPIIT) has held a meeting with major e-commerce companies, including Flipkart, Amazon, Snapdeal, Pepperfry, Paytm Mall, etc. to discuss listing of Geographic Indication (GI) registered products on their platforms. To promote GI, Government is contemplating on making GI tagging and display of logo mandatory for listing of GI registered products on e-commerce platforms by creating a separate category for these products on their platforms.






### **Updates: Uttarakhand Jyan Salt Tea**

The Geographical Indication (GI) Registry, Chennai refused to grant the GI tag to Uttarakhand Jyan Salt Tea, in an order dated 14th July 2020 on the grounds that it is a "newly coined terminology and no historical reputation was established" by the applicant and therefore it does not qualify to obtain the GI tag. Further, the applicant was not able to prove the historical data and origin of the product.

The Directorate of Agriculture, State of Jammu and Kashmir has been granted the Geographical Indication registration for Kashmir Saffron for its unique qualities such as high aroma, deep colour, long and thick threads (stigmas). The Kashmir Saffron is the only saffron grown at high altitude, which adds to its uniqueness and differentiates it from other saffron varieties available in the market.




