

# Delhi High Court granted an ex-parte interim injunction in a case involving a patent of the compound 'Apixaban'

The Delhi High Court in the case of Bristol-Myers Squibb Ireland Unlimited v Micro Labs Limited [IA No. 7681/2021] granted an ex-parte injunction in favor of the plaintiff in a case involving a patent of the compound 'Apixaban'. Apixaban products had been listed by the defendant on various third-party websites under the name 'Apivas' and this was identified to infringe the plaintiff's patent in Apixaban.

# Delhi HC grants interim injunction against using trademark 'Delhi Public International School' and 'DPIS'.

In the case of Delhi Public School Society v Delhi Public International School [I.A. 8152/2021], the Delhi High Court restrained the defendant from using the trademark 'Delhi Public International' and 'DPIS' and granted an interim injunction in favor of the plaintiff.

## Bombay High Court stayed the investigation on a Pune Police FIR.

In the case of Sony Pictures Network India Pvt Ltd v State of Maharashtra [Criminal Writ Petition No. 2929 of 2021], Karad Urban Co-operative Bank (KUCB) alleged that the 3rd episode of web series, 'Scam 1992: The Harshad Mehta Story' displays a logo in the background which resembles its trademark, causing severe damage to its financial, commercial, and social reputation.

## Delhi HC restrains kitchenware firm from using 'AMUL' trademark.

In the case of Gujarat Cooperative Milk Marketing Federation Ltd & Anr v Maruti Metals & Anr, the Delhi High Court granted an ex-parte ad-interim injunction in favor of the plaintiff and alleged that the defendants were using misleading mark 'Amul Cookware' for selling kitchenware and utensils by violating plaintiff's trademark in 'AMUL'.

## Calcutta HC refused to grant an interim injunction in telecasting of certain films.

In the case of RDB and Company v Zee Entertainment Enterprises [IA No GA/1/2021], the Calcutta High Court refused to grant an interim injunction in a case involving the telecasting of certain films by Zee Entertainment on their satellite channels and OTT Platform in which the plaintiff claimed ownership of copyright.
