In this blog writing competition, we invite you to explore the intersection of AI and IPR and to share your thoughts and insights on the challenges and opportunities presented by these rapidly evolving technologies. Some potential topics to consider might include but are not limited to:

- The role of IPR in protecting AI inventions and innovations
- The ownership and use of AI-generated data
- The ethical implications of AI decision-making
- The impact of AI on traditional notions of creativity and authorship
- The legal challenges of regulating AI and IPR

### Submission Deadline:

The last date to submit the blog is 16th April 2023 (Sunday, until 11:59 PM). No entries after this date will be considered for review.

### Formatting Guidelines:

- The manuscript submitted must be typed in Times New Roman.
- The line spacing must be 1.5.
- The font size of the title should be 14, (Headings – Size12 – Bold and Underlined – Justified)
- Body text – Size 12
- The text should be justified.
- Blogs exceeding 15% of plagiarism will be outrightly rejected.
- The blogs so submitted would be assumed to be an original piece of work of the author(s) and have not been published or is in consideration for publishing in any other place.

### About the Trivia

The trivia is based upon the basics of IPR. There will be two rounds that will be conducted on the same day. The rounds are:

1. MCQ Quiz
2. Rapid Fire Round

#### Round 1: The Elimination Round

It would consist of 20 questions. Every correct answer would be marked as 10. Only 5 participants will qualify Round 1 and proceed to Round 2.

#### Round 2: The Final Round

The qualifying participants would have 10 questions, each for 20 marks.

The trivia would be conducted through Google meet.

The participants are supposed to keep their camera switched on throughout the duration of trivia.

### How will it be conducted?

- It will be conducted on Google Meet.
- Round 1 would be conducted through a Google form.
- The results of round 1 will be announced as soon as the round will be over at the meet.
- Round 2 will be a live rapid-fire round in the presence of judges and the team.

All law students of 3-year/ 5-year courses or LLM are eligible to participate in this trivia.
