

1. Background and Introduction

The criminal justice system in India is undergoing rapid transformation, with increasing emphasis on scientific evidence, procedural integrity, and rights-based investigation. While law schools provide rigorous theoretical instruction on criminal law, evidence, and procedure, students often have limited opportunities to engage with the practical and investigative dimensions of crime-solving.

To address this academic gap, the National Crimes Investigation Competition is conceptualised as a first-of-its-kind experiential learning platform that simulates real-life investigative challenges. This national-level competition will recreate the stages involved in criminal investigation—from crime scene assessment to evidence analysis, witness examination, and preparation of a final investigation report.

The initiative aims to provide law students with a multi-disciplinary, skill-oriented learning environment that encourages critical reasoning, legal analysis, and professional ethics in the field of criminal justice.

2. Purpose and Rationale

Indian courts have repeatedly emphasised that improper investigation compromises the entire justice delivery process. As modern crimes become more sophisticated, tomorrow's legal professionals must possess a deeper understanding of investigative techniques, forensic science, and procedural mandates.

The Competition addresses this need by:

- Bringing hands-on investigation to legal education
- · Integrating forensic understanding with criminal procedure
- Encouraging students to think like investigators and litigators
- Exposing participants to practical challenges such as contradictory statements, missing evidence, or procedural lapses
- . Promoting interdisciplinary learning between law, forensics, and criminology

By engaging with realistic case scenarios, students will gain insights into how evidence is collected, preserved, analysed, and later tested in court.

3. Objectives

The Competition is designed to:

- Strengthen participants' understanding of the New Criminal Codes.
- Develop investigative thinking, logical reasoning, and analytical skills.
- Provide exposure to technical aspects such as chain of custody, forensic documentation, and admissibility of evidence.
- Improve communication and teamwork through coordinated investigative strategies.
- Train students to prepare structured investigation reports that can withstand judicial scrutiny.
- Enhance professional ethics and encourage a rights-sensitive approach to investigation.
- Create a national platform for interaction between students, legal practitioners, law enforcement officers, and forensic experts.



4. Format of the Competition

The Competition will be conducted in four comprehensive stages, each designed to replicate a real-life investigative step:

4.1 Preliminary Round - Case File Analysis

- Each team receives a fictional but realistic case file consisting of FIR, witness statements, autopsy/medical reports, forensic clues, call data records, and circumstantial evidence.
- Participants must identify legal issues, inconsistencies, and probable leads.
- Teams submit an Investigation Strategy Document, outlining their proposed approach, potential suspects, and procedural considerations.

4.2 Crime Scene Simulation (Physical)

- Shortlisted teams will visit a mock crime scene set up by the organising committee.
- Participants must observe, document, and collect evidence, ensuring compliance with investigative protocols.
- They will prepare a Crime Scene Report with sketches, photographs, observations, and preliminary deductions.

4.3 Witness & Suspect Examination Round

- Teams interact with trained actors simulating witnesses, suspects, or victims.
- Participants must frame relevant questions, test credibility, and extract material information ethically.
- Marks will be awarded based on question framing, legal compliance, communication skills, and ability to identify contradictions.

4.4 Final Round - Comprehensive Investigation Briefing

- Finalist teams present a consolidated investigation file before a panel including criminal lawyers, retired police officers, forensic experts, and academicians.
- The presentation must include sequence of investigation, evidence interpretation, findings, legal provisions involved, and proposed charges (if any).
- Judges will evaluate clarity, accuracy, legal justification, and practical application.

5. Learning Outcomes

Upon completion of the Competition, participants will:

- Gain real-world experience in crime investigation methods.
- Learn to analyse evidence holistically and apply legal principles practically.
- Understand the challenges investigators face in balancing speed, accuracy, and procedural fairness.
- Improve skills in drafting, presentation, interviewing, and legal reasoning.
- Become better prepared for careers in criminal litigation, prosecution, defence practice, investigative agencies, or judicial services.

6. Target Group and Eligibility

- Open to undergraduate and postgraduate law students from recognised universities and law schools across
 India.
- Teams may consist of 3 members with diverse skill sets in research, analysis, and communication.
- Prior experience in criminal law or moot courts is welcome but not mandatory.

7. Resource Persons and Jury Panel

The event will engage an interdisciplinary panel, which may include:

- Retired IPS officers, CBI officials, or senior police personnel
- Forensic scientists and experts from leading laboratories
- Senior advocates specialising in criminal law
- Academicians from reputed law universities
- Judicial officers (subject to consent and availability)

Their collective expertise will add authenticity to the simulation and enhance student learning.

8. Expected Impact

The Competition is expected to:

- Establish a benchmark for experiential criminal law training in India.
- Encourage universities to prioritise crime investigation as a key part of legal education.
- · Promote professionalism, independent thinking, and legal awareness among budding lawyers.
- Foster dialogue between institutions and law enforcement for long-term collaboration.
- Create an annual national platform for recognition of talent in criminal investigation.

9. Conclusion

The National Crimes Investigation Competition is a transformative academic initiative that merges legal knowledge with practical investigative skill-building. By immersing students in realistic crime-solving scenarios, the event aims to nurture competent, ethical, and well-informed future practitioners in the criminal justice system. The Competition aspires to become a flagship national event that inspires innovation and excellence in legal education.
