- b. To enter the Contest, entrant may enter by text message or mail-in entry beginning on Monday, August 5, 2019 at 12:01am MST and ending on Sunday, November 24, 2019 at 5:00PM MST ("Entry Period").
  - i. To enter via text message, text the Keyword "TOUCHDOWN" to 620620 within the time period specified to enter the Contest. Only one entry per Keyword per person is permitted. By texting to enter the Contest, the listener consents to receive automated messages about the Contest on his or her cell phone. Standard message and data rates may apply. The frequency of automated message(s) that an individual may receive after entering the Contest may vary. If you wish to stop receiving text messages, you can text STOP to cancel such messages.

Terms are available at the Station's Terms of Use. Station assumes no responsibility for charges incurred for text messaging, including, without limitation, any text messages or Contest notices from the Station. To be eligible to win, entrants in the Contest must provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers, and date of birth to verify eligibility. P.O. Boxes are not permitted as addresses.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of Arizona Twenty One (21) years of age or older, and who reside in Maricopa County. Void where prohibited or restricted by law.
- b. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes.
