If you're a Cornerstone Care Dental patient and either uninsured or underinsured, our Smile Care Program offers payment assistance for basic dental care services, thanks to funding from the Delta Dental Community Foundation.

To be eligible for our Smile Care Program, begin by:

- 1. Applying for the Sliding Scale Fee Plan
- 2. Completing the Smile Care program application
- 3. Showing proof of U.S. residency and/or citizenship/Immigration status
- 4. Providing proof of family unit size and gross household income
- 5. Showing proof of Cornerstone Care as your Dental Home, such as dental exam, treatment plan or dental services

Most recent tax returns

Accepted Includes:

- Two of the most recent pay stubs (if employed)
- · Photo ID **Documentation** • Two utility bills in applicant's name with the correct address
 - · Notarized letter if no income
 - · Child's birth certificate if applicable





Smile Care PROGRAM Benefits

- If approved, most patients receive significant assistance for the general dentistry services provided under the program.
- The level of benefit is determined by the information contained in the application.

Per Adult Under 18 Yrs.

Preventive Care Capped @ \$175/Yr. Not Capped

Restorative Care Capped @ \$350/Yr. Not Capped

Specialty Care Capped @ \$500/Yr. Capped @ \$500/Yr.

- Even insured patients could be eligible for reduced co-pay and deductible expenses, with discounts ranging from a nominal charge to a 60% discount on services.
- Patients who can provide documented proof of hardship may apply for a fee waiver. A Cornerstone Care financial representative will help you.

Special Notes:

- Only patients who have established a dental home with Cornerstone Care are eligible for assistance with dentures up to a maximum of \$500 per patient. Remakes are not covered.
- Full disclosure of all financial assets is to be included in the application including rents and royalties, checking, savings and investment account balances; interest, stocks and bonds and other cash and financial investment accounts.
- Eligible adult patients may only receive Smile Care benefits under one category of care as defined in the Sliding Fee Scale. Children under the age of 18 are not limited to a single category of care.
- Uninsured children applying for Smile Care benefits must be referred to a health insurance provider and parents must apply for appropriate health insurance coverage.
