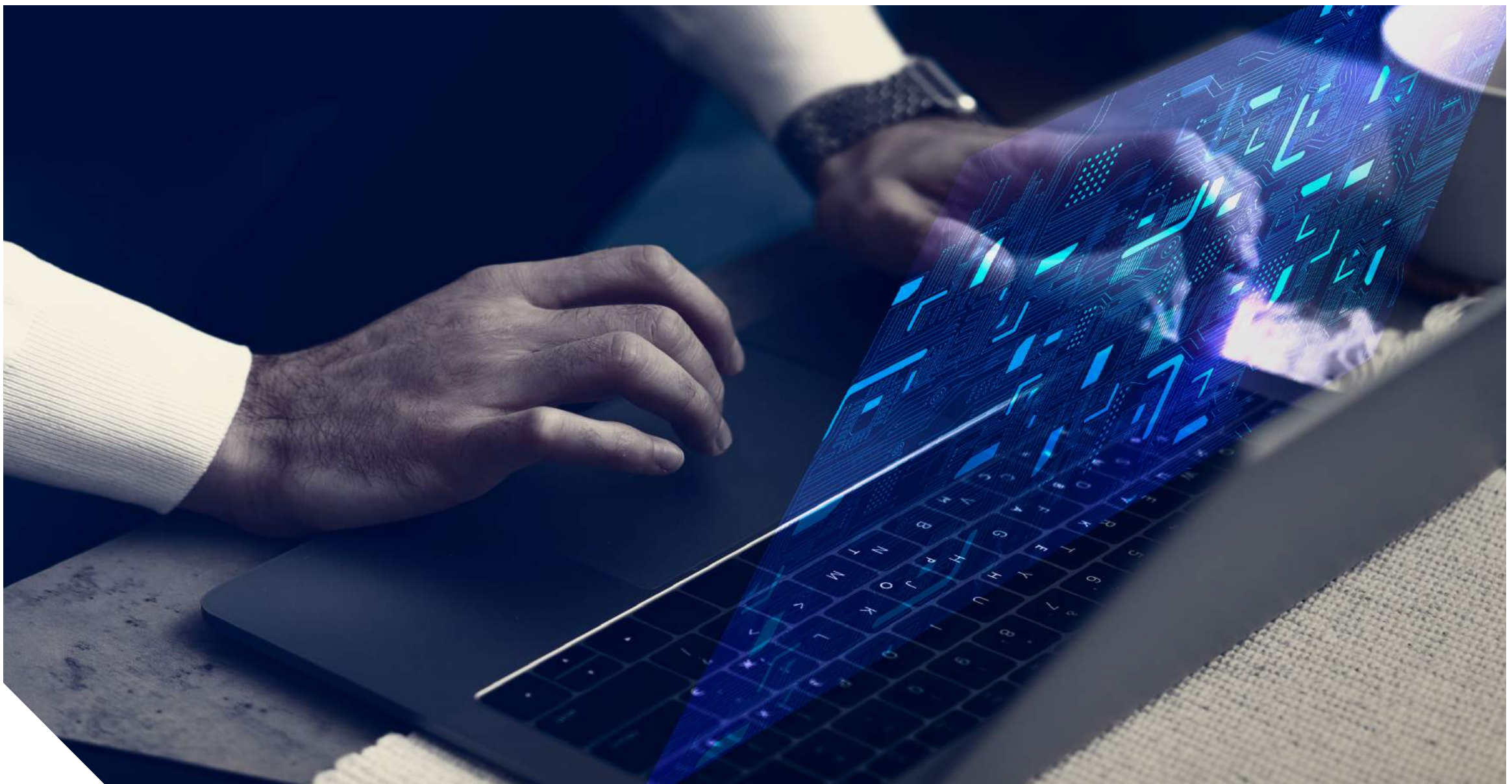
Enterprise Resource Planning Systems

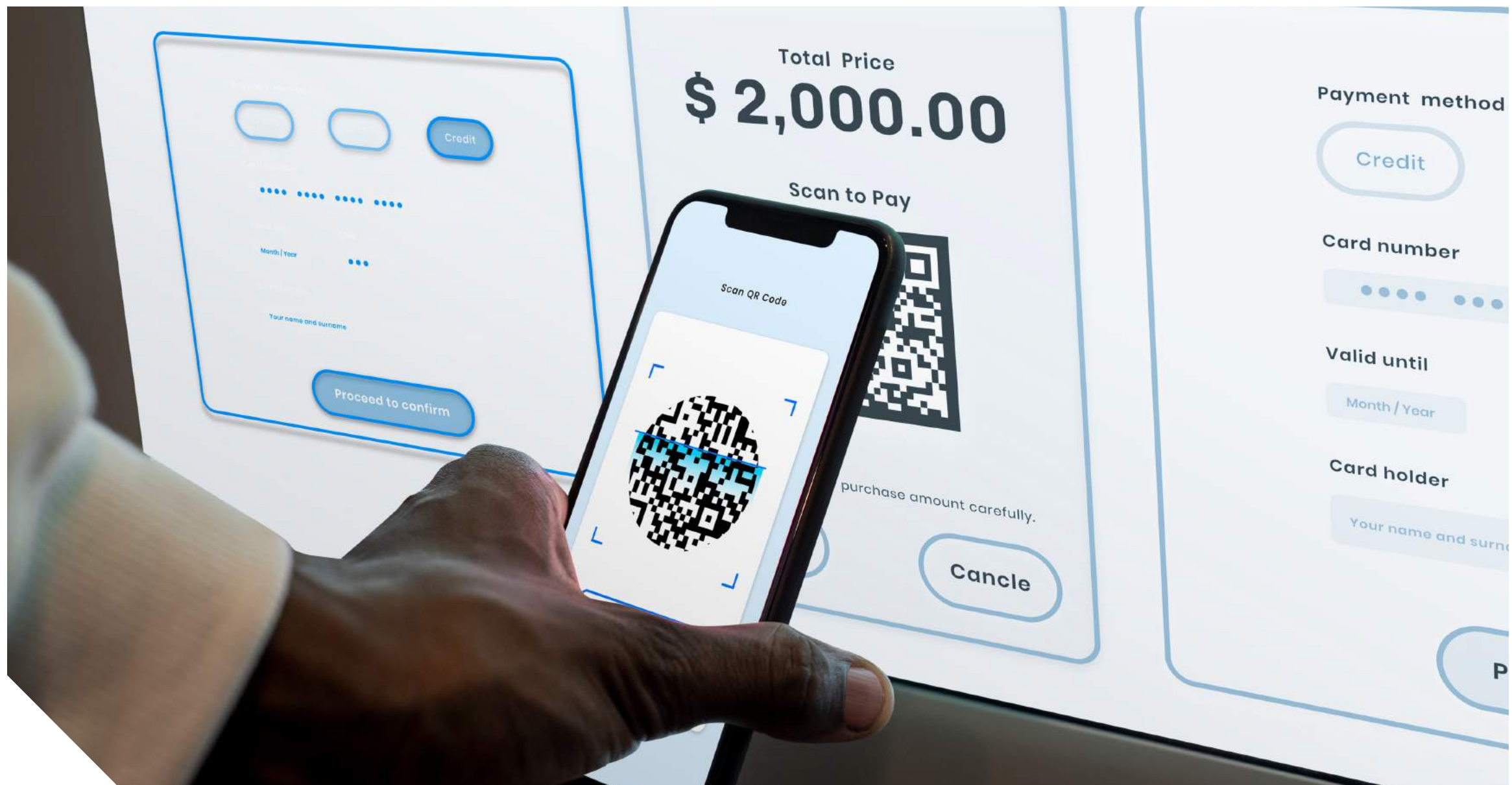
Integration Platform IPaaS

Human Resource

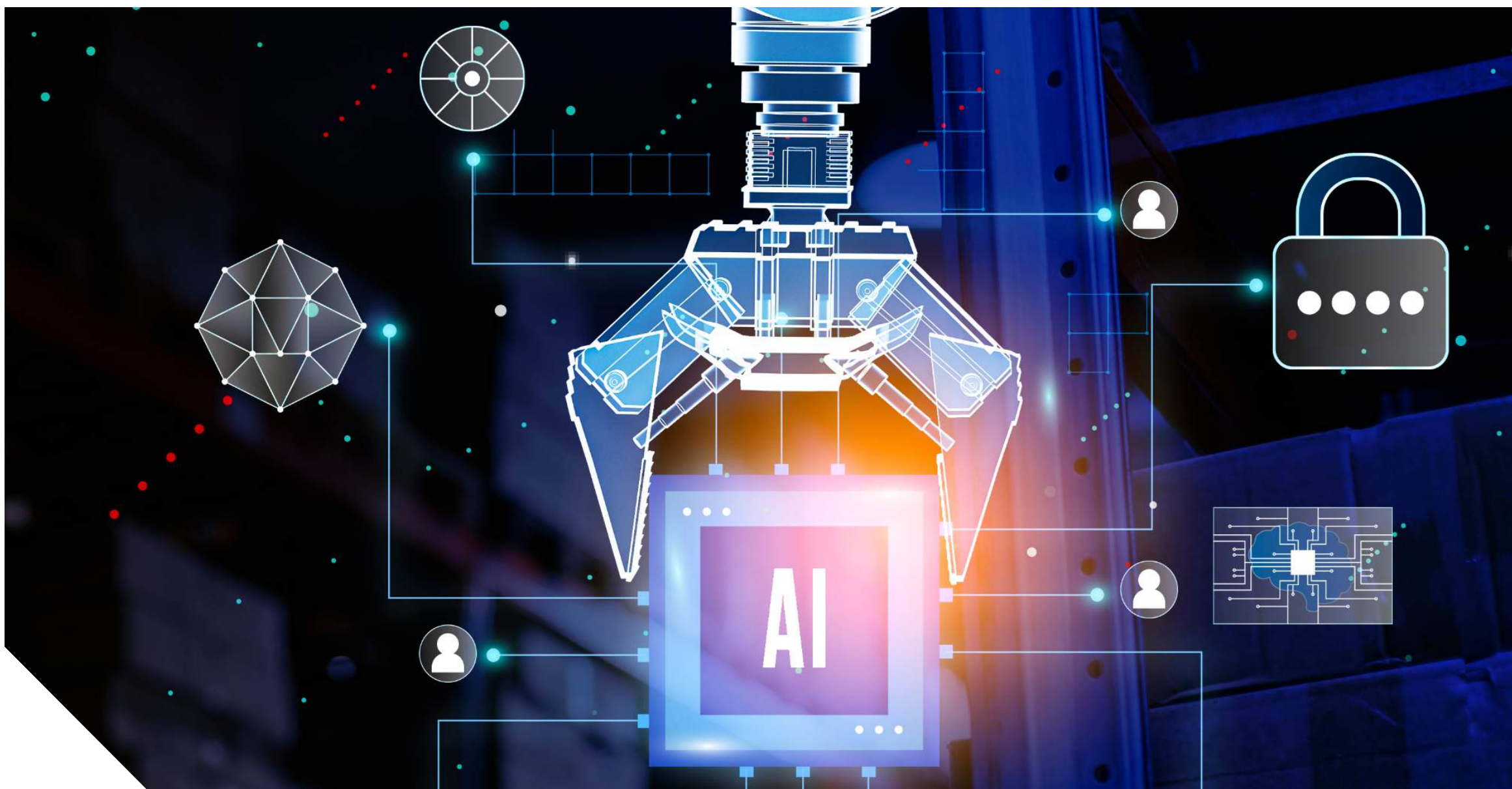
