OVERVIEW

The November 2025 meeting of the Off The Road Tyres (OTR) & Conveyor Belts Industry Advisory Committee focused on outcomes of recent TSA Round Trip Summit with Tyrewise New Zealand, recent and upcoming government inquiries and reports and TSA's market development program. Each topic included an open discussion on members' views and insights, value and impact and TSA's role.

ROUND TRIP SUMMIT

Lina Goodman (TSA CEO) presented an overview of the recent Round Trip Summit held in October jointly with Tyrewise, New Zealand's tyre product stewardship scheme. Attendance exceeded TSA's expectations with 237 registered and a significant waiting list. The Summit featured 47 speakers (of which 13 were from international organisations). More than 40 strategic introductions were made before and after the event.

TSA initiated a post-event survey of attendees and received very positive feedback from 73 respondents (35% response rate) regarding the Summit overall, the content presented and opportunity to network and engage in robust conversations. Nearly all respondents said the Summit exceeded or met their expectations and would attend a similar event in the future.

Committee members also shared positive feedback about the event and offered the following opportunities for improvement:

- Logistics in relation to recycling and methods and models to help bring costs down
- Understand constraints to recovery from mining companies

TSA noted the desire and intent to work more closely with the sector in New Zealand to have a combined voice in global forums and to more effectively share research, programs and other initiatives





As an action from the Summit, at present, 20 organisations have agreed to have their name added to a letter to the Minister requesting government increase the use of crumb rubber in roads. Committee members discussed the factors blocking greater uptake, and it was also noted that without further action from government, some businesses may fail. Members agreed TSA should continue to advocate on this issue.

Lina noted a pilot project between TSA and Canegrowers around Bundaberg. It is the first pilot for TSA working directly with the agriculture sector.

GOVERNMENT INQUIRIES AND REPORTS

Lina Goodman (CEO) presented information on the Western Australian government's report "National End-of-Life Tyres Options Project." There was a broad reaching discussion on next steps, including designing a mandatory product stewardship scheme with industry and the role of TSA to co-ordinate.

Committee members agreed as the product stewards, TSA should co-ordinate a report that outlines the characteristics needed in broad-based products stewardship scheme for tyres in Australia, with input from representatives from across the supply chain. This will provide government with necessary information required in a cost benefit analysis or RIS.

Lina Goodman noted that the House of Representatives Standing Committee on Industry, Innovation and Science launched an *Inquiry into the Australian Tyre Industry*. Submissions are open to the public, committee members were encouraged to make a submission. Lina confirmed TSA would be making a submission.

MARKET DEVELOPMENT

Lina Goodman (CEO) presented information on current market development initiatives highlighting:

- Small Project Boost aimed at promoting uptake with investments of <\$50K.
- Market Development Open Campaign ongoing campaign to support projects meeting guidelines and application process, internal reviews and final approval of the TSA board. Investments in such projects range from \$50K - \$350K.
- Aspirational Profits projects in support of a circular processes such as pyrolysis and devulcanization with potential projects including retreading support and roads stimulus.
- Research Support exampled include tyre particle wear, composition or technology.

Committee Members suggested TSA prioritise the following topics:

- Logistics methods and models (as noted earlier in communique).
- Potential for on-site shredding to address the logistics issue.
- Potential for interest in explosive accelerants by miners.

COMPLIANCE

The group discussed the complication created by the lack of necessary waste codes for conveyors belts does not allow appropriate tracking. Conveyor belts being left on farms is causing confusion about proper management at end-of-life.

Committee members noted that most agri-businesses want to tell a 'good story' about recycling their tyres, but costs are prohibitive. TSA intends to continue to investigate and invest understanding how to best support greater recovery of tyres in the agricultural sector.

The need to work with regulatory authorities on waste codes with the aim to prevent conveyor belt stockpiling was agreed. It was suggested that waste codes, on-farm storage and EPA burial licences for conveyor belts should be addressed together.

OTHER BUSINESS

As the IAC meetings are new, format for future meetings was discussed.
