INTEGRATED SEXUAL AND REPRODUCTIVE HEALTH



Working Towards Universal Access to Sexual and Reproductive Health Services and Information



Maternal Health and Midwifery

1. Acceleration of the Reduction of Maternal Mortality Ratio (MMR) through:

- a. Development of the national roadmap and the Presidential Regulation on accelerating the reduction of MMR.
- b. Enhanced use of the integrated referral information system (SISRUTE) and maternal and perinatal death notification application.

2. Strengthening the Capacity of Indonesian Midwives through:

- a. Synchronization of educational curriculum with midwifery professional standards and standardization of Recognition of Past Learning (RPL) curriculum.
- b. Training of 71 midwifery supervisors and coaching of 217 midwives in Lampung, Central Jakarta, Bekasi District, Surabaya, and Makassar.
- c. Endorsement of five new Centers of Excellence for Midwifery Education in addition to the existing five, review of national midwifery curriculum, and capacity building for midwifery faculties.

Reproductive Health and Family Planning

1. Ending Unmet Need for Family Planning through:

- a. Appointment of 34 public and private hospitals in each province in Indonesia as centers of excellence for family planning services.
- b. Promotion of postpartum family planning through e-flyers and national radio public service announcements (PSA).
- c. Engagement of 60 national partners from government institutions, civil society organizations (CSOs), donors, academics, and private sectors in the achievements of the global Family Planning 2020 (FP2020).
- d. Selection of pilot areas for integrated planning and budgeting for Reproductive Health (RH) programme for acceleration of maternal mortality reduction in five districts: Brebes (Central Java), Garut (West Java), East Lombok Timur (East Nusa Tenggara), Serang (Banten), and Jember (East Java). We were able to conduct advocacy visits to all Head of Districts and endorsed the National Working Group Team decree for the programme.







Health Sector Response to Gender-based Violence

1. Ending Gender-based Violence and Harmful Practices through:

- a. Guidelines for female genital mutilation (FGM) prevention in the health sector as part of the Roadmap to Preventing FGM/C 2030.
- b. Three national protocols of health sector response to gender-based violence (GBV) for health workers in community health centers (Puskesmas) and local hospitals and strengthening of Center of Integrated Services for the Empowerment of Women and Children (P2TP2A) to accelerate the implementation of Law No. 12/2022 on Sexual Violence Crime (UU TPKS).
- c. Review of local midwifery curriculum and integration of minimum initial service package (MISP), and revision of three national protocols of health sector response with the Indonesian Midwives Association (IBI).



HIV Prevention

1. HIV Prevention among Female Sex Workers through:

- a. Provision of oral fluid test (OFT) kits, HIV prevention packages, and information to 70,084 female sex workers.
- b. Testing of 38,637 female sex workers for HIV, and ensuring those tested HIV can access treatment, care, and other supporting services.
- c. Recruitment and capacity building of 132 peer leaders from the community and 504 peer educators into the female sex workers outreach programme.







2. HIV Prevention in Humanitarian Response through:

- a. Study on ageing with HIV in 10 cities/provinces, and access to HIV prevention, care, support and treatment for female sex workers with disabilities in DKI Jakarta during the COVID-19 pandemic with Jaringan Indonesia Positif (JIP).
- b. Development and endorsement of guidelines and module for facilitators on comprehensive HIV and sexually transmitted infections (STIs) services in health crises at community level.
- c. Capacity building on GBV case management for people living with HIV (PLHIV), and comprehensive HIV/STIs prevention in disaster situations in five cities/provinces.
- d. Distribution of 262 dignity kits to PLHIV affected by disasters in six cities/districts.
- e. Provision of cash voucher assistance (CVA) for 277 women, pregnant women, adolescents, and people with disabilities living with HIV in seven provinces and three districts.

3. Improving Women's Health and Wellbeing through:

Training of 417 women workers from 16 factories that have further trained 9,077 colleagues through the Women's Health and Wellbeing (WEALTH) project in collaboration with the Indonesian Planned Parenthood Association (PKBI) DKI Jakarta and H&M Group.





1. Continuation of SRH and GBV Services in Emergency Situations through:

- a. Development of standard operating procedures (SOP) and guidelines for Minimum Initial Service Package (MISP), HIV prevention and management in humanitarian settings, integrated gender and gender-based violence (GBV) management, mental health and psychosocial support (MHPSS) for GBV survivors; and remote and online services for GBV service providers.
- b. Development of the National Population and Family Planning Board (BKKBN) Regulation on Family Planning Programme and Services in Health Crisis Situations (Peban BKKBN No 32/2020 on Family Development, Population, and Contraceptive Services in Health Crisis Situations).
- c. Endorsement and dissemination of Minister of Women's Empowerment and Child Protection Regulation No. 13/2020 which includes GBV in emergencies (GBViE) minimum indicators in humanitarian situations.
- d. Support for the establishment and strengthening of sexual and reproductive health in emergencies (SRHiE) and GBViE sub-cluster coordination in emergency situations in West Sulawesi, South Kalimantan, and NTT Provinces, Garut, and Lumajang Districts.
- e. Implementation of the MISP and GBV prevention and management as part of disaster response in West Sulawesi, South Kalimantan, East Nusa Tenggara, and East Java provinces.
- f. Provision of SRH services and information to 13,975 people affected by disasters; distribution of 4,350 dignity kits and 3,633 protective personal equipment (PPE).

2. Accountability through Community Engagement through:

- Development of an integrated feedback mechanism for SRH and GBV issues through community engagement with 2,080 women in Central and West Sulawesi.
- b. Training of 150 female religious leaders and 50 peer educators on SRH and GBV from faith perspective with Fatayat Nahdlatul Ulama (NU).
- c. Community engagement activities that reached 5,500 women and 1,650 adolescents in West Java, DI Yogyakarta, and Central Sulawesi.

3. Capacity Building for Humanitarian & Health Workers through:

Training on MISP for SRH sub-cluster members in East Nusa Tenggara, Central Sulawesi and West Sulawesi, on delivering SRHiE services for 740 midwives nationwide, on MISP for doctors, nurses, and volunteers, and on Psychological First Aid (PFA) and MHPSS.



ADOLESCENTS & YOUTH



Enabling Meaningful Participation, Leadership, and Equal Access

1. Improving Adolescent Sexual and Reproductive Health **Education through:**

- a. Bringing together MOH and Ministry of Education, Culture, Research and Technology (MoECRT) through a Memorandum of Understanding to implement a structured, joint and accredited teacher capacity building programme on adolescent sexual and reproductive health (ASRH) education.
- b. Development of a module for ASRH education outside of school settings, training of health providers on delivering ASRH education through adolescent health posts (Posyandu Remaja), and provision of ASRH education to 5,848 students (72% girls) in 10 districts.
- c. Training of teachers on ASRH education for students with intellectual disabilities from 54 schools in 11 provinces.

2. Strategic Use of Demographic Dividend for Strategic Planning **Development through:**

- a. Updating of the 2021 Youth Development Index (YDI) and its projection in the National Medium Term Development Plan (RPJMN) goals in 2024 due to the impact of the COVID-19 pandemic.
- b. Development of guidelines and training modules for using YDI for improving the government's capacity in developing and implementing YDI at national and provincial levels.
- c. Development of the National Action Plan on School Aged Children and Adolescent Wellbeing for coordination mechanisms among government institutions in advancing adolescent wellbeing.
- d. Support for the Ministry of National Development Planning (Bappenas) in bringing together and developing a coordination mechanism with the Coordinating Ministry for Human Development and Culture (Kemenko PMK) and the Ministry of Youth and Sports (Kemenpora) to implement the national strategy on Youth Entrepreneurship.





3. Ensuring Adolescent and Youth Participation in SDGs, ICPD, and Humanitarian Action through:

- a. Establishment of a national online platform for young ASRH content creators, the Community of Practice (CoP) for content creators, which currently has 39 members with a combined reach of more than 250,000 young people.
- b. Acting as the Asia-Pacific regional hub for Digital Sexuality Education (DSE) and organization of Digital Sexuality Education Conference (DESIRE) 2021that brought together more than 240 creators and stakeholders.
- c. Strengthening of the SDGs Youth Hub, an online platform for young people and youth networks in supporting the government to achieve Sustainable Development Goals (SDGs) in Indonesia.



4. Meaningful Youth Engagement through:

- a. Development and launch of a model of meaningful engagement of young people in collaboration with MOH, JIP, Yayasan Siklus Sehat Indonesia, and five youth networks (Inti Muda, Pilar PKBI, Kisara Bali, UNALA Youth, and Centra Muda).
- b. Capacity building for three youth organizations in Yogyakarta, Central Java, and Bali on comprehensive sexuality education (CSE), relevant DSE skills, pedagogy, facilitators skills, and organizational strengthening.
- c. Capacity building for 100 young people in key populations in seven provinces on building confidence, public speaking, results-based management, and youth-adult partnership and networking among others.



GENDER EQUALITY





Addressing Heightened Risk of Gender-based Violence amid the COVID-19 Pandemic

1. Elimination of Gender-based Violence & Harmful Practices through:

- a. Technical support provided to the Ministry of Women's Empowerment and Child Protection (KPPPA) on the 2021 Indonesian National Women's Life Experience Survey (SPHPN), whose key findings were launched in December 2021 for further advocacy for elimination of violence against women (VAW) in Indonesia.
- b. Drafting of National Strategy on the Elimination of VAW available for 2022 Presidential Regulation
- c Policy dialogues and campaign conducted by the National Commission on Violence Against Women (Komnas) Perempuan for the endorsement of elimination of sexual violence bill (RUU TPKS).
- d. Development of a manual for community engagement in GBV Prevention for community intervention, linked with KPPPA's Women and Children
- e. Friendly Village (DRPPA) programme. Integration of FGM data into the 2021 SPHPN and Inclusion of FGM as a KPPPA's achievement indicator of the Sustainable Development Goals Target 5.3.2: proportion of girls and women aged 15-49 who have undergone FGM by age.



- f. Strengthened advocacy networks that engage religious leaders (including the Indonesian Women Ulema Network/KUPI), Islamic boarding schools, youth, and health sector (including IBI members) in preventing and eliminating FGM.
- g. Recommitment of Islamic boarding school and ulemas in strengthening government policies and programmes on FGM stated through the Tausyiah Bogor, an advocacy document developed from the second National Ulema Meeting.



- h A manual for youth on the prevention of FGM/C available and Youth Advocates networks established and capacitated for FGM prevention and advocacy.
- i. Mannual for Behavior Change Communication (BCC) on reproductive health for the prevention of child marriage, and community engagement on GBV Prevention for civil society organizations (CSOs), communities, and at-risk women and girls developed and available for child marriage prevention programme
- j. Joint studies on COVID-19 impact on child marriage and gender-based violence (GBV) available as an evidence based advocacy for child marriage prevention in covid19 situation
- 2. Gender Equality Advocacy through assessment and policy brief on gender perspective for the new Indonesian capital city to further advocate for gender mainstreaming in the new capital city masterplan.

3. Ensuring Comprehensive & Inclusive Multi-sectoral Services for **Gender-based Violence Survivors through:**

- a. Development of SOP for SAPA 129, the national referral mechanism for GBV survivors and capacity building for seven Centers of Integrated Services for the Empowerment of Women and Children (P2TP2A) in Cirebon, Palu, Sigi, DKI Jakarta, Tangerang, and Bogor to improve services and align them with Essential Service Package in development and humanitarian settings, including during COVID-19 pandemic.
- b. Revision of 3 protocols on Health Sector Response (HSR) to GBV to support multi-sectoral services for GBV case management and documentation of best practices and lessons learned of HSR to GBV pilot programme in Cirebon district, West Java.
- c. Procurement and distribution of 1,000 personal protective equipment (PPE) to GBV frontliners in Bekasi, Yogyakarta, Cirebon, Situbondo, and Kupang.





4. Community Organizing for Gender Norms Transformation through:

- a. Development of the Roadmap and Action Plan for the integration of gender transformative approaches into community mobilization for programme implementation to address toxic masculinity and promote positive gender norms at local and national levels.
- b. Documentation of best practices and lessons learned of a pilot project on GBV and harmful practices prevention using male involvement approach for advocacy and adaptation at national and sub-national level

5. Protection for People with Disabilities and Older Persons through:

- a. Mapping and assessments on the issues that women with disabilities and older women face during the COVID-19 pandemic in Bekasi, Cirebon, Yogyakarta, Situbondo, and Kupang for further advocacy on the rights of women with disabilities and older women.
- b. Development of 3 (three) modules on: I) inclusive protection and care for women with disabilities; II) inclusive SRH and GBV prevention for older women and women with disabilities; and III) advocacy for village fund that is responsive to women with disabilities and older women, with five disabled people's organizations for capacity development of women with disabilities and older women in exercising their rights.

6. Capacity Building for Humanitarian & Health Workers through:

- a. Strengthened capacity of 168 GBV and SRH sub-cluster members to improve cross-sectoral collaboration for integrated services.
- b. Capacity building on gender-based violence in emergencies (GBViE) prevention and management for 233 members of 41 CSOs in DKI Jakarta, Banten, West Java, and West Nusa Tenggara on GBViE prevention and management.
- c. Capacity building on self-care and risk factors of GBV frontliners to vicarious trauma for 306 GBV frontliners in self-care and risk factors to vicarious trauma.

- c. Voluntary National Review (VNR) on The Implementation of the 2030 SDGs in the impacts of Covid-19 Pandemic in Indonesia
 - The inclusion of people with disabilities.

 - The inclusion of Older Persons
 - The inclusion of Gender
- d. Evaluation on Jampersal
- e. Male Involvement in Family Planning Programme in Indonesia

4. Strengthening Data and Information Management on Disaster Risk Reduction through:

- a. Development and testing of an electronic tool for reproductive health data collection (E-Cohort).
- b. Inclusion of the MISP indicators into the MOH's Rapid Health Assessment Tools.
- c. Development and utilization of the UNFPA Humanitarian Microsite for information sharing and facilitating RH and GBV sub-cluster coordination.

5. Advocacy for ICPD+25 Agenda through:

- a. More than 1,000 social media posts across four platforms that gained 32,228 engagements and over 36 online events that gathered more than 58,000 views on Youtube.
- b. Three South-south and Triangular Cooperation (SSTC) for family planning and sexual and reproductive health training sessions for participants from four Asian and nine African countries, as well as religious leaders and young people from the Bangsamoro Autonomous Region in Muslim Mindanau (BARMM), the Philippines.
