Directives for the Establishment of the Program Scholarship**

Article 1 The National Taiwan University (“the University”) International College Master’s Program in Smart Medicine and Health Informatics (“the Program”) formulates the *Directives for the Establishment of the Program Scholarship* (“the Directives”) to establish the Program Scholarship (“the Scholarship”) and attract outstanding students to study at the Program.

Article 2 The Scholarship is intended for the Program’s current students with official student status at the University, as well as prospective students admitted by the Program.

Article 3 The number of scholarships awarded under this scholarship program shall be flexibly adjusted according to the annual budget and the number of students. The content of the scholarships under this program is categorized based on the review results as follows:

1. Full tuition and miscellaneous fee waiver or subsidy;
2. Half tuition and miscellaneous fee waiver or subsidy.

Awarded students who have already received a waiver or subsidy for tuition and miscellaneous fees shall provide the payment receipt to this program. The program will then proceed to issue the scholarship after verification.

Article 4 The application procedures for the Scholarship shall be as follows:

1. New students: The program shall determine the recipients and Scholarship amounts during its new student admissions reviews.
2. Current students: Current students may apply with the Program in

accordance with the application time frame and procedures announced by the Program each year.

Article 5 Each student in the program may be awarded the Scholarship only once, and the duration of the Scholarship shall be as follows:

1. New students: 2 years
2. Current students: 1 year (from September of the current year to August of the following year)

Article 6 Upon conclusion of the first year of the Scholarship, new students who have been awarded the Scholarship shall meet the following criteria and other conditions described in the Program's Scholarship announcement for the year, submit a report, and obtain the approval of the Program's Scholarship Committee in order to continue receiving the Scholarship in accordance with the originally approved terms:

1. Having a grade point average (GPA) of 3.5 or better in the previous academic year
2. Having never received any warnings or more severe penalties issued by the University

Article 7 Scholarship recipients who fail to register for a given semester or who do not actually enroll in the University; who apply for deferred admissions, suspension, or withdrawal; or whose eligibility has been terminated by the Program's Scholarship Committee shall no longer receive Scholarship funds.

Article 8 Scholarship recipients who are found to have forged or falsified their application documents shall have their eligibility revoked by the Program. Furthermore, said recipients shall return all Scholarship payments already received and be held accountable for any liability based on the seriousness of the offense.

Article 9 The Scholarship shall be funded by the Program's self-raised funds as well as subsidies from the University.

Article 10 The Directives shall be passed by the Program Committee, College Affairs Meeting, and Administrative Meeting and then implemented on the date of promulgation.
